Lost Ten Tribes of Israel Found in Britain?

I have found at least ten times in which someone has set a date for Christ's return at the beginning of a jubilee year. These dates are posted <u>HERE</u>. Moses had told the Israelites that, after they entered the Promised Land, they should begin counting sabbaticals of seven years each, and, in the seventh sabbatical, in the fall, on the 10th day of the seventh lunar month, they would be allowed to return to their settlement, which Joshua had originally given them (Leviticus 25:8-16).

The Balfour Declaration

Moses also said that, in the fall of the 49th year, on the day of Atonement, those who had been driven from their land should return to their land Joshua had given their ancestors and expel other occupiers. This view seemed especially significant after the Balfour Declaration on November 2, 1917 described <u>HERE</u>. It allowed the Jews to return to their homeland in Israel.

It was commonly believed that, when the Messiah would come, they would return and take with them all of their proselytes, those who had joined their Messianic, Messianic Christian, and Hebrew Roots movements. This would include the Millerites, Adventists. Church of God Seventh Day and Mormans (who think they are modern-day Israelites).

The Messiah was to come to rule and draw His people back to Palestine, and this tempts us to expect the Messiah in a jubilee year... if only we knew just when this would be. Everyone seems to have his or her own dates.

Below are six Messianic Movements I've discovered, which are based upon <u>what was believed</u> to be a jubilee year at the time. The first four dates are described <u>HERE</u>.

Jubilee Speculation

Here are the last six of the ten dates set for Christ's return, which begin with number five:

5. In 1844, the Millerites predicted that Christ would return on the day of Atonement to begin a jubilee year, and the Jews would return to Palestine to get their land back. They calculated that it was 2300 years after 458 BC if the jubilees were 50 years apart (Dan. 8:14). (Note: 458 BC is also related with the alleged 490 years of Daniel 9.)

6. After the Great Disappointment, many of the Millerites branched off forming the Seventh Day Adventists and the Church of God Seventh Day, and each had their own publishing facilities.

Moreover, a minister of the Church of God Seventh Day was a neighbor of Herbert W. Armstrong in Oregon, and he shared his literature with the Armstrongs until he could eventually sign Armstrong's ministerial license.

Thus, Armstrong was exposed to literature on British Israelism, which says the Throne of David is currently in London, and Christ will sit on this throne <u>transferred to Jerusalem</u> when He rules all nations. The United States and British are allegedly God's covenant people who are allegedly destined to rule all nations. This seems somewhat like the view that the Germans are the master race. More details on British Israelism are found <u>HERE</u>.

This undoubtedly explains why, in 1944, Armstrong said Christ would fight Hitler and Mussolini when he returned. This was about 100 years after 1844; perhaps it was another 50-year jubilee.

7. 1975 appeared to be a jubilee calculated in a different way. It was 69 jubilees after Joshua crossed the Jordan in 1407 BC ($69 \ge 49 = 3381$) (1406 + 1975 = 3381).

8. In contrast, 1975 would also be a 50-year jubilee if the jubilees began at creation just like the jubilee during Richard de Lionheart was calculated from creation using 49-year jubilees.

1975 is calculated by dating the Era of Abraham as 2016 BC (as in Eusebius' work) and by adding to it 2008 more years back to Adam. This would place Creation in 4024 BC and would make 1975 the end of 6000 years after Adam (6000 - 1975 AD = 4025 BC).

9. It is likely there will be more dates set in the near future based upon the jubilee year. <u>2022 will be the 17th jubilee</u> since De Lionheart's jubilee. It will be the <u>42nd jubilee after Herod</u> captured Jerusalem in a sabbatical year. It will be the <u>48th jubilee after Alexander</u> allowed the Jews to continue observing their sabbaticals tax free after 331 BC. It will be the <u>118th jubilee</u> <u>after the rabbinical date of creation</u>, the 122nd jubilee after the true date of creation.

10. If there were jubilees in 84 AD and 132 AD, there would also have been one previously in 35 AD, when Paul was called to send the gospel to all nations. This implies that the Jews expected their Messiah to expel the Romans and give them their land back during the previous seven years from 27 to 34 AD. It did not happen, and the Jews were bound to keep setting other dates for their Messiah.

These ten anti-Christian movements based upon incorrect dates for the coming of the Messiah should act as a precaution for those who are exposed to literature from the Hebrew Roots, Christian Messianic, Latter Day Saints, semi-Jewish, and Zionist movements.

U.S and Britain are Israel in Prophecy?

This return after 1917 sparked another messianic movement, and many began wondering just where the Israelites had been scattered and where they are presently located. Where will they be before they return to their land? Some researchers concluded that the U. S. and British had become a great nation and a company of nations promised to Abraham. Therefore, Israelites today are allegedly the United States and Britain.

This was proposed to explain that Britain and America are God's people who are destined to join with the Messiah at His return and thereafter rule over all nations. Christ would allegedly sit upon David's throne, which, allegedly, had been brought to Ireland and transferred to Scotland and then brought to England.

One of the highlights of this study is to investigate and compare different views previously devised. Rabbinical Jews have their dates, and Christian Messianic Jews have theirs. These false dates have one thing in common, and that is false dates for the jubilee.

Evidence Against the U.S. and Britain Being Israelites

Several books were written on how the "Lost Ten Tribes" of Israelites left Assyria and traveled across northern Europe into the British Isles and America. These were written long before we could collect and compare y-dna sequences (the y chromosome) passed down from grandfather to father to son and grandson. Now we can determine that the Norsemen (northern Europeans), the Danish, Normans, the Vikings, Scottish, Irish, Welsh and English were in haplogroup R1b1.

Now that we have these y-dna tools, the followers of this view now have to explain how those early inhabitants could be in haplogroup R1b1. If the Jews should match the other ten tribes, why are they in haplogroups J, J1 and J2 and not in R1b1?


Haplogroups change into other haplogroups as a result of mutations. In a simplistic view, haplogroup mutates and creates a branch called haplogroup B, and B develops a branch called C, and C forms D. This continues down to J, K, L, M, N, O, P, Q, and R. Each haplogroup has sub groups. For instance, J has sub groups J1, J2, J2a, J2a4h, J2a4h, etc. R has sub groups R1, R1b, R1b1, etc. Whole groups, like the Vikings can be characterized as R1b1. Phoenicians and Hebrews canb characterized as J1 or J2, but Vikings are not J1 or J2. Jews are not R1b1.

Earliest Haplogroup is A

Perhaps mutations take place to adjust to a new environment.

Even fungus mutates. If placed in a drought environment, it can go through many generations in only a few weeks and, in that amount of time, they can adjust to a new, very wet environment. Of course, humans don't mutate that quickly.

Since the Anglo-Israel Association believes that the Israelites were the Norsemen (northern Europeans), the Danish, Normans, the Vikings, Scottish, Irish, Welsh and English, they must also believe the Israelites were in haplogroup R1b1, which came after J, J1 and J2. Their solution? Simply turn the y-dna chart upside down as presented <u>HERE</u> and <u>HERE</u> as in the following chart, and explain that mutations cause losses in each haplogroup.



This suggests that life is not just adaptive but also creative. Does this suggest that dna can become more complex to adapt to the colder climates and become simpler when adjusting to hotter climates? Allegedly, mutations can create a loss within the dna structure making the sequence simpler. Perhaps others are blaming this loss on exposure to sunlight and radiation at the equator. This would allegedly show that new haplogroups are the result of degeneration, the result of mutations causing a reduction in genetic material and becoming simpler.

This suggests the opposite of evolution creating each haplogroup more complex implied in the standard, accepted view. More research is needed.

Nevertheless, I1, a simpler haplogroup, is found in only 6% of the Welsh, in northern Europe. Over 80% of Welsh are R1b. The next highest is I1 at only 6%.

Moreover, R1a and R2 are also found, not just in the north, but throughout Pakistan, India, Russia, the Poles, Ukrainians, Norwegians, the Vikings and Normans. Thus, they are of the most complex haplogroups. Therefore, it seems doubtful that the Israelites were ever R1b1. The middle East is mostly J, J1 and J2.


The Problem of Having Jewish Sephardic and Askenazi Y-dna

The accepted view is that haplogroups are arranged from group A to J and from J to R, not visa versa. It is believed that Noah's grandson, Gomer, spread over northern Europe and had a son named Askenazi (Gen 10:3). Therefore, these were born of Noah's son Japheth and are not Semetic and very likely were R1b1. Noah's son, Shem, was semetic, and became the ancestor of Eber or Heber (the Hebrews) within the J, J1 and J2 haplogroups. Perhaps the differences in the haplogroups of Japheth and Shem were influenced by the mtdna of their wives and their dna prior to Noah's flood. Again, more research is needed.

Askenazi existed as a tribe in the time of Jeremiah 51:27, after the temple fell in 587 BC. Eventually, the Askenazi were identified as Germans. It is explained <u>HERE</u>. If true, then they were likely haplotype R1b1 like the Vikings, the Norsemen, and the British Isles.

In contrast, there was a Jewish center in Worms, Germany, and others that spoke Yiddish German, and the Askenazi used Hebrew letters to write in German After removing to eastern Europe, they were referred to as Askenazi Jews, but they were not R1B1. They were J2, actually Jewish, not just converts to Zionism.

As a final proof that the haplogroups go from A to R, not R to A, here is the accepted beginning from A to A1b1b before changing into group B. This is from the labs of FamilyTreeDNA (ftdna.com). It is explained <u>HERE</u> and illustrated here:



First American Settlements Were R1b1, not Israelite

It can be shown that the nine dynasties of Europe are not J1 or J2 or Jewish by clicking <u>HERE</u>. The Vikings were R1b1, and so was Normandy, Scotland, Ireland, Wales and England.

After coming to Virginia, Jamestown, Williamsburg and Richmond were R1b1. The French Huguenots settled in Manakintown near Richmond and were R1b1. Some were German and Welsh. The Germans (Gomer) were R1b1. The Welsh were R1b1 like the Jones' and Hughs'. The Petersburg was founded by Peter Jones of Wales, and Hat Creek and Entry Creek had many Welshmen, and Thomas Jefferson was Welsh.

German Town was settled by German immigrants hired to dig for various metals to make bullets, axes and guns.

Interest in Cursing America

More research is needed to prove the early settlements were from any of the lost ten tribes of Israel. Therefore it is doubtful that any of the prophecies alleged to be for the Israelites of our time are directed toward the United States.

However, if it is true that 2022 is the beginning of a jubilee year, this does not prove the Messiah will curse America at that time. God has blessed America.

A famous singer once said, "I've never met a Jew that didn't have a book to sell." Likewise, Christ said that the Jewish scribes would travel to (or send books to) the ends of the earth to make one proselyte like himself (Mat 23:15).

For example, there's *The Bible Code*, which claims that every letter of every word in the Bible has been miraculously preserved since Moses, but it fails to mention that the Masoreh Text only preserved the consonants and not the vowels. If in doubt, one must learn Hebrew or ask a Jew about their Hebrew Roots.

Likewise, Jonathan Cahn has written *The Harbinger* about the secret of America's future. *The Mystery of the Shemitah* covers what has happened in 2001, 2008 and 2015, during the Jewish sabbaticals. At the end of the book, he covers an alleged 50-year jubilee cycle in 1917, 1967 and 2017, which is not compatible with the 2001, 2008, and 2015 49-year cycle. Eventually, he will likely set an eleventh date for the coming of the Messiah based upon the jubilee.

Defining the "Lost 10 Tribes of Israel" as being America

During the World War II, Adolph Hitler was claiming that Germany was the Master Race that would rule the world for 1,000 years. In 1943, books were being freely distributed showing that King George VI was sitting on king David's throne, and all nations would serve him until Christ comes to transfer the throne to Jerusalem (see *Morning Cometh*, by the British-Israel Association of Greater Vancouver).

These were not the first to make such claims. Pope Pius XII claimed to be merely holding his seat for Christ, which would be transferred to Jerusalem. The Mormons claimed to be the ten tribes of Israel then existing in early America.

Much time and effort had gone into collecting proofs supporting their theories, and if something disproves their evidence, like y-dna and the FamilyTreeDNA projects, they simply turn the evidence upside down to influence their simple-minded less-informed followers and continue espousing beliefs about a first covenant, second covenant and a more special third covenant. To do this they must interpret many prophecies about Israel's return from Babylon and apply them to modern times. They must deny that both the house of Israel and the house of Judah were in Babylon in the time Ezekiel met them at the river Chebar and ignore the idea that the "valley of dry bones" in Ezekiel 37 is about their return to Israel in the time of Cyrus, and ignore or diminish the idea that Christ has already become a spiritual king and spiritual priest over a spiritual kingdom after the first century.
